We have one public hearing on the agenda, for the consideration of assuming the powers and duties of the Macon County Board of Health Pursuant to North Carolina General Statute §153A-77. A copy of the notice of public hearing is included in the packet and was published in the July 23, 2025 edition of *The Franklin Press*.

Following the close of the public hearing, the board may take action.

County Attorney Eric Ridenour can provide additional guidance and information as needed.

§ 153A-77. Authority of boards of commissioners over commissions, boards, agencies, etc.

In the exercise of its jurisdiction over commissions, boards and agencies, the board (a) of county commissioners may assume direct control of any activities theretofore conducted by or through any commission, board or agency by the adoption of a resolution assuming and conferring upon the board of county commissioners all powers, responsibilities and duties of any such commission, board or agency. This section shall apply to the board of health, the social services board, area mental health, developmental disabilities, and substance abuse area board or any other commission, board or agency appointed by the board of county commissioners or acting under and pursuant to authority of the board of county commissioners of said county except as provided in G.S. 153A-76. A board of county commissioners exercising the power and authority under this subsection may, notwithstanding G.S. 130A-25, enforce public health rules adopted by the board through the imposition of civil penalties. If a public health rule adopted by a board of county commissioners imposes a civil penalty, the provisions of G.S. 130A-25 making its violation a misdemeanor shall not be applicable to that public health rule unless the rule states that a violation of the rule is a misdemeanor. The board of county commissioners may exercise the power and authority herein conferred only after a public hearing held by said board pursuant to 30 days' notice of said public hearing given in a newspaper having general circulation in said county.

The board of county commissioners may also appoint advisory boards, committees, councils and agencies composed of qualified and interested county residents to study, interpret and develop community support and cooperation in activities conducted by or under the authority of the board of county commissioners of said county.

A board of county commissioners that has assumed direct control of a local health board after January 1, 2012, and that does not delegate the powers and duties of that board to a consolidated health service board shall appoint an advisory committee consistent with the membership described in G.S. 130A-35.

- (b) In the exercise of its jurisdiction over commissions, boards, and agencies, the board of county commissioners of a county having a county manager pursuant to G.S. 153A-81 may:
 - (1) Consolidate certain provisions of human services in the county under the direct control of a human services director appointed and supervised by the county manager in accordance with subsection (e) of this section;
 - (2) Create a consolidated human services board having the powers conferred by subsection (c) of this section;
 - (3) Create a consolidated county human services agency having the authority to carry out the functions of any combination of commissions, boards, or agencies appointed by the board of county commissioners or acting under and pursuant to authority of the board of county commissioners, including the local health department, the county department of social services, or the area mental health, developmental disabilities, and substance abuse services authority; and
 - (4) Assign other county human services functions to be performed by the consolidated human services agency under the direction of the human services director, with policy-making authority granted to the consolidated human services board as determined by the board of county commissioners.
- (c) A consolidated human services board appointed by the board of county commissioners shall serve as the policy-making, rule-making, and administrative board of the consolidated human services agency. The consolidated human services board shall be

composed of no more than 25 members. The composition of the board shall reasonably reflect the population makeup of the county and shall include:

- (1) Eight persons who are consumers of human services, public advocates, or family members of clients of the consolidated human services agency, including: one person with mental illness, one person with a developmental disability, one person in recovery from substance abuse, one family member of a person with mental illness, one family member of a person with a developmental disability, one family member of a person with a substance abuse problem, and two consumers of other human services.
- (1a) Notwithstanding subdivision (1) of this subsection, a consolidated human services board not exercising powers and duties of an area mental health, developmental disabilities, and substance abuse services board shall include four persons who are consumers of human services.
- (2) Eight persons who are professionals, each with qualifications in one of these categories: one psychologist, one pharmacist, one engineer, one dentist, one optometrist, one veterinarian, one social worker, and one registered nurse.
- (3) Two physicians licensed to practice medicine in this State, one of whom shall be a psychiatrist.
- (4) One member of the board of county commissioners.
- (5) Other persons, including members of the general public representing various occupations.

The board of county commissioners may elect to appoint a member of the consolidated human services board to fill concurrently more than one category of membership if the member has the qualifications or attributes of more than one category of membership.

All members of the consolidated human services board shall be residents of the county. The members of the board shall serve four-year terms. No member may serve more than two consecutive four-year terms. The county commissioner member shall serve only as long as the member is a county commissioner.

The initial board shall be appointed by the board of county commissioners upon the recommendation of a nominating committee comprised of members of the preconsolidation board of health, social services board, and area mental health, developmental disabilities, and substance abuse services board. In order to establish a uniform staggered term structure for the board, a member may be appointed for less than a four-year term. After the subsequent establishment of the board, its board shall be appointed by the board of county commissioners from nominees presented by the human services board. Vacancies shall be filled for any unexpired portion of a term.

A chairperson shall be elected annually by the members of the consolidated human services board. A majority of the members shall constitute a quorum. A member may be removed from office by the county board of commissioners for (i) commission of a felony or other crime involving moral turpitude; (ii) violation of a State law governing conflict of interest; (iii) violation of a written policy adopted by the county board of commissioners; (iv) habitual failure to attend meetings; (v) conduct that tends to bring the office into disrepute; or (vi) failure to maintain qualifications for appointment required under this subsection. A board member may be removed only after the member has been given written notice of the basis for removal and has had the opportunity to respond.

A member may receive a per diem in an amount established by the county board of commissioners. Reimbursement for subsistence and travel shall be in accordance with a policy set by the county board of commissioners. The board shall meet at least quarterly. The chairperson or three of the members may call a special meeting.

- (d) The consolidated human services board shall have authority to:
 - (1) Set fees for departmental services based upon recommendations of the human services director. Fees set under this subdivision are subject to the same restrictions on amount and scope that would apply if the fees were set by a county board of health, a county board of social services, or a mental health, developmental disabilities, and substance abuse area authority.
 - (2) Assure compliance with laws related to State and federal programs.
 - (3) Recommend creation of local human services programs.
 - (4) Adopt local health regulations and participate in enforcement appeals of local regulations.
 - (5) Perform regulatory health functions required by State law.
 - (6) Act as coordinator or agent of the State to the extent required by State or federal law.
 - (7) Plan and recommend a consolidated human services budget.
 - (8) Conduct audits and reviews of human services programs, including quality assurance activities, as required by State and federal law or as may otherwise be necessary periodically.
 - (9) Advise local officials through the county manager.
 - (10) Perform public relations and advocacy functions.
 - (11) Protect the public health to the extent required by law.
 - (12) Perform comprehensive mental health services planning if the county is exercising the powers and duties of an area mental health, developmental disabilities, and substance abuse services board under the consolidated human services board.
 - (13) Develop dispute resolution procedures for human services contractors and clients and public advocates, subject to applicable State and federal dispute resolution procedures for human services programs, when applicable.

Except as otherwise provided, the consolidated human services board shall have the powers and duties conferred by law upon a board of health, a social services board, and an area mental health, developmental disabilities, and substance abuse services board.

Local employees who serve as staff of a consolidated county human services agency are subject to county personnel policies and ordinances only and are not subject to the provisions of the North Carolina Human Resources Act, unless the county board of commissioners elects to subject the local employees to the provisions of that Act. All consolidated county human services agencies shall comply with all applicable federal laws, rules, and regulations requiring the establishment of merit personnel systems.

- (e) The human services director of a consolidated county human services agency shall be appointed and dismissed by the county manager with the advice and consent of the consolidated human services board. The human services director shall report directly to the county manager. The human services director shall:
 - (1) Appoint staff of the consolidated human services agency with the county manager's approval.
 - (2) Administer State human services programs.
 - (3) Administer human services programs of the local board of county commissioners.
 - (4) Act as secretary and staff to the consolidated human services board under the direction of the county manager.
 - (5) Plan the budget of the consolidated human services agency.
 - (6) Advise the board of county commissioners through the county manager.

- (7) Perform regulatory functions of investigation and enforcement of State and local health regulations, as required by State law.
- (8) Act as an agent of and liaison to the State, to the extent required by law.
- (9) Appoint, with the county manager's approval, an individual that meets the requirements of G.S. 130A-40(a).

Except as otherwise provided by law, the human services director or the director's designee shall have the same powers and duties as a social services director, a local health director, or a director of an area mental health, developmental disabilities, and substance abuse services authority.

MEETING ROOM LEASE AGREEMENT

THIS LEASE AGREEMENT, made and entered into this the ____ day of ______, 2025, by and between the COUNTY of MACON, a political subdivision of the State of North Carolina, hereinafter, "County," and NANTAHALA COMMUNITY DEVELOPMENT CLUB, a North Carolina non-profit corporation with its principal place of business in Macon County, North Carolina, hereinafter, "Nantahala."

WITNESSETH:

WHEREAS, the County is the owner of that approximate 1.36-acre tract or parcel of land located at 36 White Oak Lane, Topton, Macon County, North Carolina, bearing PIN 6526271654 and more particularly described in Book Z-40, Page 93 of the Macon County, Registry.

WHEREAS, Nantahala holds its regular meetings in the conference room located in the northern half of the structure located upon the above referenced parcel.

WHEREAS, in the opinion of the duly elected Board of Commissioners of the County of Macon, it has been determined that there is presently not a foreseen need for the use of said property for public purposes of the County; and

WHEREAS, the Board of Commissioners of the County of Macon has found that the conference/meeting room located in the northern half of the structure is currently surplus to the COUNTY's needs; and

WHEREAS, upon Resolution duly approved by the Board of Commissioners of the County of Macon, the execution of this Agreement has been approved; and

WHEREAS, Nantahala desires to lease the hereinafter described real estate, and improvements thereupon, and has agreed to maintain the property, clean it after every use, and allow the public entry to attend their meetings and gatherings during this time, pursuant to the terms set forth herein.

NOW, THEREFORE, for and in consideration of the matters and things to be performed by the NANTAHALA, hereinafter enumerated, the COUNTY does hereby let and lease unto NANTAHALA and the NANTAHALA does hereby lease from the COUNTY, the following described property, to-wit:

The conference/meeting room located in the northern half of the structure located on that approximate 1.36 acre tract or parcel of land, with an address of 36A White Oak Lane, Topton, Macon County, North Carolina, bearing PIN 6526271654 that

consists of the conference room and kitchen together with shared use of the restrooms with the Nantahala Public Library located within the same structure. The land on which the structure is located is more particularly described in Book Z-40, Page 93 of the Macon County, Registry. hereinafter the "leased premises,"

The terms and conditions of this Agreement are as follows:

1.	The term of this Lease shall be for a period of one year, and shall begin on		2025
and unless soo	ner terminated as hereinafter provided, shall terminate on	, 2026.	

- 2. As rental for the Leased Premises, NANTAHALA shall pay unto the COUNTY an annual rental of One Dollar (\$1.00), the same to be payable in advance upon the execution hereof. In addition, NANTAHALA shall be responsible for cleaning the conference room, bathrooms and kitchen and shall keep the grounds picked up and free from rubbish.
- 3. The Leased Premises shall be used for public "recreation" as that term is defined by N.C. Gen. Stat.§ 160A-352 ("Recreation" means activities that are diversionary in character and aid in promoting entertainment, pleasure, relaxation, instruction, and other physical, mental and cultural development and leisure time experiences).
- 4. NANTAHALA shall provide substantial recreational opportunities to the public within the Leased Premises and shall make the Leased Premises open and available to members of the general public's use.
- 5. NANTAHALA agrees to perform its obligations herein in a nondiscriminatory fashion appropriate for public activity and there shall be no discrimination based on race, sex, national origin, religion or otherwise.
- 6. NANTAHALA shall provide routine and general housekeeping maintenance necessary to maintain the Leased Premises in good, clean and attractive condition. COUNTY shall be responsible for substantial maintenance such as HVAC and roof repair.
- 7. NANTAHALA shall make no changes or alterations to the Lease Premises without the prior written approval of the COUNTY.
- 8. NANTAHALA understands and agrees that the Leased Premises are located within the same structure containing the Nantahala Public Library, hereinafter "Library," that the bathroom facilities within the structure are shared with the Library and that employees of the Library are to be provided with a key or coded badge to access the Leased Premises for the use, recreation and public events sponsored by the Library.
- 9. NANTAHALA shall maintain an online calendar with the Library and shall communicate and work in harmony with the Library in scheduling events within the Leased Premises. If the Library needs access to the Leased Premises at a time that was not previously scheduled, the Library is expected to give notice to Nantahala at, or if possible, prior to, the time that access is made.
- 10. No portion of the Leased Premises shall be sub-leased without the prior written approval of the COUNTY, except NANTAHALA may charge a reasonable use fee of \$10 per hour

for private gatherings and meetings not otherwise open to the public, except no fee shall be charged when the Leased Premises are used by the Library.

- 11. NANTAHALA agrees to save the COUNTY harmless from all claims for damages to person or property occurring in or on the leased Premises and shall indemnify COUNTY for any damage caused by other persons in or upon the leased Premises or caused by operation in construction of any private, public or quasi-public works.
- 12. Should NANTAHALA default in its obligations under this Agreement, then and in that event, the COUNTY shall have the right to take immediate possession of the Premises, without prejudice to any and all other rights it may have to enforce the terms and provisions hereof.
- 13. At the end of the term, NANTAHALA shall return the Premises to the COUNTY, in as good a condition as when NANTAHALA took possession of the same, as improved and repaired pursuant to the prior provisions hereof, ordinary wear and tear expected.
- 14. This Agreement shall be terminable at will by either part, by giving written notice of the intention to terminate, with 30 days prior to the date of termination.

- 11(A). Mr. Seagle is requesting approval of an increase in the cost of a budgeted service that has historically cost about \$4,500 annually. The Latest invoice increased by \$8,000 without notice.
- A recent legislative change will require counties and cities to conduct SBI criminal history record checks for applicants offered a position if the position requires the applicant to work with children in any capacity. There will be several policy changes and additions needed to meet this new requirement, which becomes effective October 1, 2025. The agreement with the SBI to gain access to the Criminal History Information System (CHIS) has been accepted, and HR staff are in the process of completing training on the system, updating policies, and developing procedures. This change does not impact current employees in their current position, but could potentially impact all new hires and current employees who change positions, and prohibits new employees from beginning work until the criminal history check results have been received. The current turnaround time for the SBI is two weeks, but with the implementation of this new process statewide, the delay will most likely increase, delaying the hiring and onboarding process. Ms. Keezer is requesting approval to make the necessary policy and procedural changes necessary to meet these requirements.

New Criminal History Record Check Requirements for Some County and City Job Applicants

A new state law (Session Law 2025-16) enacted this summer will soon require all counties and cities in North Carolina to subject all applicants for positions that require working with children in any way to criminal history record checks conducted by the North Carolina State Bureau of Investigation (SBI). Read on to learn more about these new requirements, which are effective October 1, 2025.

What does the new law require counties and cities to do?

The new requirements for counties and cities are found in Part IV of <u>Session Law 2025-16</u>. For counties, the new statute is G.S. 153A-94.2(b). For cities, the new statute is G.S. 160A-164.2(b). Both new statutes impose the same requirements.

If a position being filled by a county or city "requires an applicant for employment to work with children in any capacity," every board of commissioners and city council must require the applicant, if offered the position, to be subject to a criminal history record check conducted by the SBI. These checks must be conducted in accordance with <u>G.S. 143B-1209.26</u>, the statute which authorizes the SBI to provide a fingerprint-based state and national criminal record check to cities and counties.

How does this new requirement interact with existing state law regarding criminal history record checks for city and county employees?

For two decades, <u>G.S. 153A-94.2</u> has authorized (but not required) boards of county commissioners to subject applicants for employment of any kind to a criminal history record check conducted by the SBI. <u>G.S. 160A-164.2</u> has given the same authority to city councils.

These existing provisions remain in effect, and they continue to allow local governing boards to require applicants to undergo criminal history record checks. What's new from S.L. 2025-16, as of October 1, is that local governing boards *must* require applicants for positions that will involve working with children to undergo a criminal history record check—regardless of whether the local governing board has such a requirement for other categories of applicants. Counties and cities should review their personnel policies and ordinances to ensure that the new requirements regarding positions that require working with children are properly reflected.

To which city or county positions will these new requirements apply?

This is the big question. The new statutory provisions—G.S. 153A-94.2(b) and G.S. 160A-164.2(b) —do not provide a list of covered positions. Instead, they simply state that these requirements apply to any position that "requires an applicant…to work with children in any capacity."

The word "children" is not defined in these statutes. However, it would seem reasonable to assume that it aligns with the definition of "juvenile" in North Carolina's Juvenile Code, which includes any person who is not yet 18 years old and is not married, emancipated, or a member of the Armed Forces. <u>G.S. 7B-101(14)</u>.

Cities and counties will have to determine which applicants are covered by considering the expected job duties of each specific

position and whether those job duties *require* working with children in any way. It seems apparent that these new statutory provisions will apply to any position where the employee will be responsible, to any extent, for supervising, transporting, interviewing, teaching, coaching, helping, or caring for individuals under the age of 18. In the local government context, this will likely include social workers, nurses and other medical staff, parks and recreation staff, EMS employees, librarians, and other roles, each depending on the nature of the specific position's required job duties.

What must a city or county provide to the SBI for the criminal history record check?

When requesting a criminal history record check for an applicant, G.S. 143B-1209.26 requires a city or county to provide to the SBI:

- The fingerprints of the applicant;
- A form signed by the applicant consenting to the criminal record check and use of fingerprints and other identifying information required by the State and National Repositories of Criminal Histories;
- and any additional information required by the SBI.

An SBI website explaining the steps a county or city must take to access criminal history record information is available here:

NCSBI – Agency Access Agreement. Counties and cities should read and follow these steps carefully, including ensuring that any employee who may obtain or access criminal history record information understands and will comply with the terms of the SBI's agency access agreement.

How does the SBI criminal history record check process work?

The SBI uses fingerprints to search the state criminal history record file and forwards a set of fingerprints to the Federal Bureau of Investigation for a national criminal history record check. Counties and cities must pay a fee to cover the cost of the SBI's record check process (currently, \$38 for the combined national/state record check).

The city or county must keep all information that it obtains through the background check process confidential. G.S. 143B-1209.26.

When should this occur during the county or city's hiring process?

A criminal history record check must only occur *after* the county or city has extended a conditional offer of employment to an applicant, pending the results of the check. In other words, a local government should not seek to run a criminal history record check *prior to* making a conditional offer for employment, nor should the local government wait until *after* an applicant has already started working in the position before seeking the criminal history record check.

When does this new requirement for counties and cities go into effect?

These requirements become effective October 1, 2025, and apply to offers of employment made on or after that date.

Do these new provisions require counties to get criminal history record checks for their *current* employees who work with children (i.e., employees hired prior to October 1, 2025)?

No, the requirements do not apply retroactively. They only apply to offers of employment made on or after October 1.

What if a county or municipal employee is not *initially* hired into a position that requires working with children, but later transitions into such a position? Do these requirements apply at that time?

The statutes contemplate that an "applicant for employment" for a position that requires working with children must be subject to a

criminal record history check. Accordingly, the answer as to when these requirements apply to a position change during the course of employment likely depends on whether an existing county or city employee is considered an "applicant" for a different position within the county or city. For example, a county might post a position that requires working with children and have multiple internal and external candidates apply for that position. If one of those internal candidates is the preferred applicant for the role, then the new G.S. 153A-94.2(b) arguably requires the county to subject the internal candidate (as an "applicant") to a criminal history record check after making the candidate a conditional offer.

Do these new requirements apply to unpaid volunteers?

No. The new statutory provisions only apply to "applicant[s] for employment."

May an applicant request a copy of their own criminal history record information?

Yes. By law, each individual has a right to review their own criminal history record information to ensure that it is complete and accurate. *See* 14B NCAC 18B .0404; 28 C.F.R. 20.34. The SBI has more information about how an individual may obtain a copy of their own state or national criminal history record here: NCSBI – Personal Review.

MACON COUNTY BOARD OF COMMISSIONERS AUGUST 12, 2025 REGULAR MEETING MINUTES

Chairman Young called the meeting to order at 6:00 p.m. All Board Members, County Manager Warren Cabe, Deputy Clerk Tammy Keezer, Finance Director Lori Carpenter, and County Attorney Eric Ridenour were present, as were a number of county employees, media, and citizens.

ANNOUNCEMENTS:

- **(A)** Ms. Keezer announced that county offices will be closed on Monday, September 1, 2025, in observance of the Labor Day holiday.
- **(B)** Ms. Keezer shared that Macon County Maintenance and Parks and Recreation Department employees were recognized on August 12, 2025, for the outstanding work done at the Veterans' Memorial Park.
- **(C)** Mr. Cabe announced a Public Hearing is scheduled for September 9, 2025, for the purpose of considering whether the Board of Commissioners would adopt the health department as a department within the county pursuant to NCGS 153A-77.
- **(D)** Mr. Cabe reported that the Board of Health voted at their last meeting to meet monthly instead of every other month, so their next meeting will be August 26, 2025, at 6:15 p.m.
- **(E)** 828 Treasure Quest fundraiser for KIDS Place Alisha Ashe, Executive Director of Kids Place, Kellie Burns, Event Coordinator, and Lee Cloer with 828 Vibes provided an overview of the fundraiser, which will be held on Saturday, October 11, 2025.
- **(F)** Mr. Cabe announced that the Community Funding Pool funding application is live on the web page.
- **(G)** Mr. Cabe said the Highlands School renovation project is on schedule, and that the Franklin High School (FHS) parking lot should be paved by the end of the week, and that the FHS project is also on schedule
- **(H)** Mr. Cabe reported that the Board of Education wants to schedule a joint meeting in the near future.
- (I) Mr. Shields announced that the LBJ Job Corps painted the eagle at the Veterans Memorial Park and was recognized at the Veterans Memorial Park this morning.

MOMENT OF SILENCE: Chairman Young requested all in attendance rise and a moment of silence was observed.

PLEDGE OF ALLEGIANCE: Led by Commissioner Antoine, the pledge to the flag was recited.

PUBLIC HEARING(S): None

ADDITIONS AND ADJUSTMENTS TO THE AGENDA: Commissioner Shearl requested to add item 10E under Old Business, Discussion on Operations of Solid Waste, and item 10F under Old Business, Update on Animal Services, to the agenda.

PUBLIC COMMENT PERIOD: Vickie Sanders spoke about Burningtown-Iotla Fire Department (BIFD) membership, training, and the open house event. She said they have done everything that has been asked of them, and she hopes the community continues to have the BIFD. **Matt Jackson** spoke about the Board of Health and said to fix the problems, but do not tear down the whole structure. Focus on real solutions and not overreach. **Betsy Baste** said Animal Control Officers do not have enough force in issues with animal abuse and neglect, but if they were employees of the Sheriff's Department. The officers could do more. She stated that she wants to advocate for the Pawsitive Animal Volunteers who want to take over the shelter.

APPROVAL OF THE AGENDA: Upon a motion by Commissioner Breeden, seconded by Commissioner Antoine, the board voted unanimously to approve the agenda, as adjusted.

REPORTS/PRESENTATIONS:

PRESENTATION AND UPDATE ON CENTER OPERATIONS AT LBJ JOB CORPS - Vickie Sutton, Academic Manager, gave an overview of the LBJ Job
Corps center and programs offered. Keith Bowers, Business Liaison, spoke
about career readiness and transition to the workforce.

PROGRESS REPORT FROM THE HUMAN RESOURCES DEPARTMENT - HR and Safety Director Tammy Keezer introduced the Macon County Human Resource staff. HR Analyst Nina Parrott shared a PowerPoint presentation about the new real-time application process.

OLD BUSINESS:

DISCUSSION ON ADDITION TO VETERANS MEMORIAL AT THE NANTAHALA COMMUNITY BUILDING/LIBRARY - Nantahala Community Member Susan Carpenter shared a PowerPoint presentation of the vision for an additional, larger memorial. She requested permission from the board to move forward. Commissioner Shields made a motion, seconded by Commissioner Breeden, for Ms. Carpenter to proceed with the design and purchase as requested. The vote was unanimous.

DISCUSSION ON USE AND OCCUPANCY OF MULTI-USE ROOM AT NANTAHALA COMMUNITY BUILDING AND LIBRARY – Mr. Cabe indicated there was information in the agenda packet regarding the lease proposed by the Nantahala Community Development Club (NCDC), which includes a standard one-year lease option and a per-day lease option. Attorney Ridenour explained both lease options and said he hoped the per-day lease option would be acceptable to the state bingo authority. NCDC Chairman Steve Bigos said he was happy with the one-year lease and that NCDC cut the fee in half, and added the fee schedule in the version he provided. Commissioner Shearl commented that the lease stipulates the facility is to be used for community activities, and that reserving the facility for a private individual or family should not take priority over a community activity. Commissioner Breeden

said he thinks the cleanest idea is to do the daily lease because the community club meets only once a month, with the library taking over the calendar. Librarian Abby Hardison said the library space is limited, library staff are present six days a week, and they have to rely on someone from the NCDC to come in and grant them access to the space, making it difficult to plan. She said that having freedom of access would be beneficial to them in planning community activities more easily and frequently. Commissioner Young said we have discussed this for two months, and we need to make a decision. He indicated that two things must happen for him to support the lease: the library must have a key, and he would like to see claw-back provisions in the lease. Commissioner Antoine said he agrees with the terms Commissioner Young presented. Commissioner Breeden made a motion, seconded by Commissioner Antoine, to enter into a lease on a per-day basis, with the building open to the library, the library maintaining the schedule, and the library having a key to the building. In the discussion, Attorney Ridenour inquired about specific days and times required by the NCDC for Bingo, which was followed by Mr. Bigos' suggestion to disregard the lease and bingo, and instead let the library operate as it has been. Mr. Cabe said that if the NCDC does not have a lease, they cannot charge a fee for a building they do not own or lease, nor can the county provide the supplies. Commissioner Breeden withdrew his motion, stating that we do not need a lease and will operate as usual, with the library having a key for access to the NCDC side to conduct programs they have scheduled on the calendar. Commissioner Shearl made a motion, seconded by Commissioner Young, to enter into a one-year lease with NCDC, with the library having a key, a clawback clause, and a fee schedule. After further discussion, Attorney Ridenour clarified the lease details and said he would amend the lease for approval. The vote was 4-1 with Commissioners Shearl, Young, Antoine, and Shields in favor of the motion, and Commissioner Breeden opposed.

UPDATE ON BURNINGTOWN-IOTLA FIRE DEPARTMENT - Fire Marshal Jimmy Teem gave an update on inspections, membership, deficiencies, and probation status. Commissioner Shearl provided an update on the events that occurred during a recent drill, noting that there was significant resistance to the drill. He described the intent of the drill and how it is supposed to operate, and indicated that Cowee Volunteer Fire and Rescue has covered the calls in the BIFD district for the last 18 months, so the insurance rates are not impacted. Commissioner Shearl said he has no proof that BIFD can handle its district. Chief Kenneth McCaskill provided an update indicating that reports are completed on Thursday nights, and there are currently no deficient reports in the computer system. He spoke about the inspection drill and how he felt it put his community in danger. Commissioner Antoine said he realizes this is a highly emotional issue, that he views it as a safety issue, and stated that he is not hearing that if lives are on the line, they can be saved. Commissioner Shearl referred to a probationary period for members, as per their bylaws, stating that a number of the members on their roster are on probation and therefore cannot participate in calls. Chief McCaskill said those bylaws were suspended ten weeks ago, and every member has the appropriate turnout gear. He said the department was eligible to come off probation in December, but they had a missed call around the first of January, so the probation started over. Chief McCaskill said there are communication system issues, and they do not get all calls. After further discussion, Commissioner Shearl made a motion, seconded by Commissioner Antoine, to suspend the contract for BIFD. A discussion ensued about the process for contracting with another department for coverage and taking over the BIFD district, as well as merger options. The vote was 2 to 3, with Commissioners Young and Shearl in favor of the motion, and Commissioners Shields, Antoine, and Breeden opposed. Commissioner Shearl inquired whether Cowee Volunteer Fire and Rescue is still obligated to respond to calls for the BIFD district, and Mr. Cabe clarified that BIFD is still under probation, but that the decision would be made by the

board. Cowee Volunteer Fire and Rescue Assistant Chief Larry Pickens said they are unwilling to cover the calls without compensation because they have already done so for 13 months. There was a unanimous board consensus to leave BIFD on probation with monthly updates provided.

At 9:07 p.m., Chairman Young called a five-minute recess and reconvened the meeting at 9:17 p.m.

CONTINUED DISCUSSION ON EXPANDED ACCESS TO ALCOHOLIC BEVERAGES THROUGH REGULATED ON- AND OFF-PREMISES SALES –

Mr. Cabe said there was a draft resolution in the agenda packet, and that if the board were to decide they wanted to move forward, they would need to approve that resolution. He said Attorney Ridenour would also need to know which election ballot the board wanted to put the resolution on. Attorney Ridenour said if the board wanted to allow liquor sales, the County would have to operate an ABC store and put that on the ballot as well. Otherwise, beer and wine sales would be covered. He explained the resolution and the ballot process. Commissioner Breeden made a motion, seconded by Commissioner Shields, to adopt a resolution for a referendum for on- and off-premises sales to be included on the 2026 general election ballot [Attachment 1]. The vote was unanimous.

UPDATE ON SOLID WASTE - Mr. Cabe informed board members that he and the Interim Director have been working through the process, that some processes were already in place to look at Cell 2A and 2B, hauling, etc. He said the engineers put this out to bid, and the cost estimates were above what the predictions were, and that he has asked the engineers to go back to the lowest qualified bidder to validate the bid and see if we could split off Cell 2A, as well as some other options he had discussed with Interim Director Jaimie Picou. Mr. Cabe indicated that the rough estimate for hauling is \$5,000 per day, plus tipping fees. He noted that with the construction project now expected to be about a month behind schedule, he thinks we should release an RFP for hauling that includes the tipping fees. Mr. Cabe hopes to have more information at the September meeting.

UPDATE ON ANIMAL SERVICES – Mr. Cabe said we had one proposal to the RFP from a volunteer group requesting to operate the animal shelter, and that he had sent it to the Board of Health members. He said it will take some time to review the improvement requests in the proposal and that he needs to gather some people to have a more in-depth discussion, possibly arriving at an answer by the September meeting.

NEW BUSINESS:

PROPERTY BOUNDARY – Tax Administrator Abby Braswell said she was requesting approval for a geodetic survey of the county line between Macon and Swain County and explained the process. She said there are nine houses that are going to be affected. Attorney Ridenour gave a shout-out to the Tax and Mapping departments in both Macon and Swain for their work in making this happen. Commissioner Breeden made a motion, seconded by Commissioner Breeden, to approve the joint agreement as requested. The vote was unanimous.

Consideration of Revision to Article VI, Section 2 of the Macon County Personnel Policy Regarding Hospital and Medical Insurance Upon Retirement – Mr. Cabe said he is supposed to be working on a salary and benefit study, but there is a policy that we want board input on, and he thinks a change in this would help with recruitment. He said we are proposing ten

consecutive years with Macon County to be eligible for health benefits for midcareer folks upon retirement, to help with recruitment, but we are open to suggestions. He said there is a cost associated with this change, but we cannot determine that at this time because there are constant changes in how long people stay, how many people come, etc. Mr. Cabe said if this is approved, we can come back and review based on the impact. Commissioner Breeden said he likes the ten years and noted that we had discussed this for recruitment and retention, and the financial offset is probably pretty close. Commissioner Breeden made a motion, seconded by Commissioner Antoine, to approve the revision as presented. The vote was 4-1 with Commissioners Breeden, Antoine, Shields, and Young voting in favor of the motion, and Commissioner Shearl opposed.

CLASSROOMS – Planning, Permitting, and Development Director Joe Allen said during the budget process, there was discussion about roofing for the SCC mobile classrooms, and the board had requested he conduct an evaluation. Mr. Allen stated that the roofs need repair and provided pictures showing some of the issues. He also shared three quotes he has obtained, indicating that the total cost will be around \$14,819, which is significantly lower than the original request by SCC, which was \$40,000. Mr. Cabe clarified that payment for the repairs is the responsibility of SCC. Commissioner Shields made a motion, seconded by Commissioner Breeden, to approve the roof repairs as recommended. The vote was unanimous.

CONSENT AGENDA: Upon a motion by Commissioner Shearl, seconded by Commissioner Breeden, the board voted unanimously to approve the consent agenda as presented, which includes: (A) Minutes of the July 8, 2025, regular meeting, (B) Budget Amendments #10-36, (C) Renewal of Franklin Chamber Contract, (D) Renewal of Highlands Chamber Contract, (E) Reapproval/Reaffirm NC Statewide Mutual Aid Agreement, (F) Approval of Revised Voluntary Shared Leave Policy, (G) Approval of Revised Personnel Records Policy(H) Tax releases for the month of July 2025 in the amount of \$1,746.00, (I) Monthly ad valorem tax collection report – no action necessary.

APPOINTMENTS:

Macon County Board of Health (3 seats) - Mr. Cabe stated that there were two resignations on the Board of Health at their last meeting, and we immediately posted the vacancies. He said this did not allow a lot of time to receive applications, but we brought the applications we received. Mr. Cabe talked about the vacancies and the concern that the Board of Health maintain a quorum. There was some discussion about Commissioner Shearl serving as a voting member of the Board of Health in a liaison capacity, and Commissioner Breeden was appointed as a non-voting liaison; however, the board could appoint Commissioner Breeden to a vacant general public seat if they chose. Commissioner Shearl made a motion, seconded by Commissioner Antoine, to appoint Commissioner Breeden as a voting member filling the optometrist/general public vacancy. The vote was unanimous. Commissioner Young requested that we reopen the applications for two to three weeks, and Commissioner Breeden asked that we vet the physician currently serving on the board in a general public seat to determine if he qualified for the vacant physician seat.

CLOSED SESSION: At 10:14 p.m., upon a motion by Commissioner Shearl, seconded by Commissioner Breeden, the board voted unanimously to go into closed session as allowed under NCGS 143-318.11(a)(3) to consult with an attorney regarding pending litigation. At 10:20 p.m., upon a motion by

LEASE AGREEMENT

THIS LEASE AGREEMENT, made and entered into this the ____ day of _____, 202__, by and between the COUNTY of MACON, a political subdivision of the State of North Carolina, ("COUNTY"), and the GEM & MINERAL SOCIETY OF FRANKLIN, N.C., a North Carolina non-profit corporation with its principal place of business being in the Town of Franklin, Macon County, North Carolina, ("GEM & MINERAL SOCIETY OF FRANKLIN, N.C.,").

WITNESSETH:

WHEREAS, the COUNTY is the owner of the hereinafter described tract or parcel of land, upon which is located at the old Macon County Jail Building, including the Sheriff's living quarters, located at 25 Phillips Street, in the Town of Franklin, Macon County, North Carolina ("the Premises"); and

WHEREAS, the GEM & MINERAL SOCIETY OF FRANKLIN, N.C., has previously rented the Premises for a term of five (5) years, during which major improvements to the building were made, and has agreed to maintain the Premises in a good condition and to provide for the public, free of charge, gem and mineral and Indian artifact displays; and

WHEREAS, in the opinion of the duly elected Board of Commissioners of the County of Macon, it has been determined that said property, in its present condition, is not necessary for any public purpose of the County, and that there is no presently foreseen need for the use of said property for public purposes of the County during the term of this Lease; and

WHEREAS, the Board of Commissioners of the county of Macon has found said property to be currently surplus to the COUNTY's needs; and

WHEREAS, upon Resolution duly approved by the Board of Commissioners of the County of Macon, the execution of this Agreement has been approved; and

WHEREAS, the GEM & MINERAL SOCIETY OF FRANKLIN, N.C., desires to lease the hereinafter described real estate, and improvements thereupon, and has agreed to maintain the same and keep it open as a museum, available to the public, pursuant to the terms hereof;

NOW, THEREFORE, for and in consideration of the matters and things to be performed by the GEM & MINERAL SOCIETY OF FRANKLIN, N.C., hereinafter enumerated, the COUNTY does hereby let and lease unto the GEM & MINERAL SOCIETY OF FRANKLIN, N.C., and the GEM & MINERAL SOCIETY OF FRANKLIN, N.C., does hereby rent and take from the COUNTY, the following described property, to-wit:

All that certain tract of parcel of land, lying and being in the Town of Franklin, Macon County, North Carolina, on the west side of Phillips Street, and being more particularly described as follows:

BEGINNING at a concrete monument near the northwest corner of The Macon County Jailhouse, as the same is shown on the survey and Plat entitled Rankin Square, as surveyed by Gardner v. Holden, Registered Land Surveyor, under date of August 5, 1976, which plat is recorded in the office of the Register of Deeds for Macon County, North Carolina, in Plat Book 4 at page 128; runs thence from said Point of Beginning, South 18 degrees 55 minutes East 63.40 feet to the northwest corner of the old Library building; thence with the north wall of the same, North 71 degrees 05 minutes East approximately 48 feet to the west margin of the sidewalk along Phillips Street; thence with the west margin of said sidewalk, North 19 degrees 37 minutes 05 seconds East 63.32 feet to a point near the northeast corner of the old Jailhouse building; thence South 71 degrees 09 minutes West approximately 48 feet to the point of BEGINNING.

The terms and conditions of this Agreement are as follows:

1. The term of this Lease shall begin as of the beginning of	, 202	_, and
unless sooner terminated as hereinafter provided, shall continue through and	including	g the

- 2. As rental for the Leased Premises, the GEM & MINERAL SOCIETY OF FRANKLIN, N.C. shall pay unto the COUNTY an annual rental of Ten Dollars (\$10.00), the same to be payable in advance upon the execution hereof. In addition, the Gem & Mineral Society of Franklin, N.C. will annually pay the following as additional rent:
 - A The Leased Premises shall be used for public "recreation" as that term is defined by N.C. Gen. Stat.§ 160A-352 ("Recreation" means activities that are diversionary in character and

aid in promoting entertainment, pleasure, relaxation, instruction, and other physical, mental and cultural development and leisure time experiences) throughout each year of the lease;

- B It shall provide substantial recreational opportunities to the general public at such location in the nature of those which it has heretofore provided at such location and which are consistent with definition of "recreation" as that term is defined in N.C. Gen. Stat. § 160A-352 throughout each year of the lease;
- C It shall make the leased premises open and available to members of the general public during reasonable days and hours for "recreation" as that term is defined by N.C. Gen. Stat § 160A-352 for the period between ______, 202____, and the end of _______, 202____, and it shall in fact provide substantial recreational opportunities to the general public at such location and during such hours throughout each year of the lease;
- D. It agrees to perform its obligations in such lease in a nondiscriminatory fashion appropriate for public activity and there shall be no discrimination by Sublessee on the basis of race, sex, national origin, religion or otherwise throughout each year of the lease; and
- E It shall account to Macon County for its uses of resources provided by Lessor to it and for its uses of the leased premises in accordance with A, B, C and D above throughout each year of the lease.
- 3. The GEM & MINERAL SOCIETY OF FRANKLIN, N.C., shall have the right and shall be obligated to perform at its sole cost, all repairs to the interior of said building, and the roof thereof, as shall be required to keep the same in a safe and usable condition.
- 4. The GEM & MINERAL SOCIETY OF FRANKLIN, N.C., shall, at its sole cost and expense, provide all maintenance necessary to maintain the leased Premises and all portions thereof in good, same and attractive condition.
- 5. The GEM & MINERAL SOCIETY OF FRANKLIN, N.C., shall make no structural changes or alterations to exterior of the improvements upon the Premises without the prior written approval of the COUNTY.
- 6. The GEM & MINERAL SOCIETY OF FRANKLIN, N.C., shall, at its sole cost and expense, further make all improvements which may be required to insure that the Premises comply with all governmental requirements, including but not limited to the Americans with Disabilities Act.
- 7. Neither all nor any portion of the leased Premises shall be sub-leased without the prior written approval of the COUNTY.

- 8. The GEM & MINERAL SOCIETY OF FRANKLIN, N.C., shall pay all charges for the furnishings of utilities to the leased Premises, the charges therefor to be billed to the GEM & MINERAL SOCIETY OF FRANKLIN, N.C., and in no way billed or charged to the COUNTY.
- 9. The COUNTY shall not be liable for any damage to property of the GEM & MINERAL SOCIETY OF FRANKLIN, N.C., or property of other parties, or for damage to persons, whether employees or customers, having property upon or being upon the leased Premises, nor for the loss. of or damage to any property or person, by theft or otherwise. The COUNTY shall not be liable for any injury or damage to the demised Premises, persons or property resulting from fire, explosion, deficiency in the structure or any other cause of whatsoever nature; and the GEM & MINERAL SOCIETY OF FRANKLIN, N.C., agrees to save the COUNTY harmless from all claims for damages to person or property occurring in or on the leased Premises; nor shall the COUNTY be liable for any such damage caused by other persons in or upon the leased Premises or caused by operation in construction of any private, public or quasi-public works; nor shall the COUNTY be liable for any latent defects in the demised Premises. During the term of this Lease, the respective parties may carry such fire, liability and extended coverage for the benefit of both parties, with minimum limits of \$100,000.00 - \$300,000.00, and shall carry landlord-tenant standard fire and extended coverage insurance, in the maximum insurable value of the improvements upon the Premises: All proceeds from the respective insurance policies other than those required to be carried by the GEM & MINERAL SOCIETY OF FRANKLIN, N.C., (in the event of loss) shall be payable to the owner thereof, without claim of or by the other party or its insurer.
- 10. Should the GEM & MINERAL SOCIETY OF FRANKLIN, N.C., fail to pay the rent, as herein specified, or otherwise default in its obligations under this Agreement, then and in that event, the COUNTY shall have the right to take immediate possession of the Premises, without prejudice to any and all other rights it may have to collect rent, or otherwise enforce the terms and provisions hereof.
- 11. At the end of the term, the GEM & MINERAL SOCIETY OF FRANKLIN, N.C., shall return the Premises to the COUNTY, in as good a condition as when the GEM & MINERAL SOCIETY OF FRANKLIN, N.C., took possession of the same, as improved and repaired pursuant to the prior provisions hereof, ordinary wear and tear expected.
- 12. This Agreement shall be terminable at will by either part, by the giving of written notice of the intention to terminate, at least sixty (60) days prior to the date of termination.

RE: Settlement Report for 2024 Taxes

Each year the North Carolina General Statute §105-373 dictates that a series of reports be made available to the Macon County Commissioners as a part of the annual settlement for the Tax Collector. The reports that are attached are identified as follows:

- 1. A summary of the collection practices and remedies employed by the tax collector.
- 2. A financial report for the most recent fiscal year's taxes that balances all of the amounts charged to the tax collector for collection, including taxes, discoveries, penalties, fees and interest, against the amounts actually collected. (Settlement Report)
- 3. A sworn statement that states that diligent effort has been made by the Collector to collect any taxes due by reasonable means available for collection procedures.
- 4. A list of delinquent property taxes from the most recent year owed by taxpayers who do own real property in the jurisdiction. This list is further identified as the same list that was provided as the advertising list for publication in the local paper. Please note that this list was generated in April 2025, for advertisement purposes, and many of the accounts on this list have been paid in full at this time. This list is on file in the Macon County Tax Collector's Office and will be provided if needed.
- 5. A list of delinquent property taxes from the most recent fiscal year owed by taxpayers who do not own real property in the jurisdiction (personal property). This list is on file in the Macon County Tax Collector's Office and will be provided if needed.

TAX COLLECTIONS:

The Tax Collections Office staff consists of a Tax Collection Supervisor, and two (2) Deputy Tax Collectors, all of whom are certified through the North Carolina Tax Collectors Association. The collection procedure involves processing payments through checks, cash and electronic payments. Property owners may pay their taxes through the mail, phone-based transactions, on-line, in person and through a secure drop-off box located in front of the annex building. Many accounts are also paid through an electronic process utilized by escrow companies, service companies and by Auto-Agent, which is a software program that mortgage/escrow companies utilize in order to eliminate 98% of refunds.

The collections office staff utilizes diligent effort to collect both the current year taxes and any delinquent taxes. Collection of the current year taxes involves the processes as mentioned above as well as a lockbox service, which is provided through the Wells Fargo bank. This service involves Wells Fargo staff electronically processing payments, with a report provided to the office staff daily, with payments processed and balanced by the collections staff on the same day. In addition, this staff works closely with escrow companies, service companies and Auto-Agent to electronically process payments that are forwarded each year. As always, we process payments on-site, and service many property owners who pay directly through our office.

We have increased the use of enforced collections through this office in recent years. Enforced collections involve processes utilized to collect delinquent taxes. These processes include: garnishment of bank accounts, garnishment of Department of Revenue returns, garnishment of rents or other dollars held by a third party, and as a last resort, the foreclosure process.

As noted above, the foreclosure process is now utilized in this office with successful results. We contract with attorney Victoria Smith, of Ridenour & Goss to handle our foreclosures. The mortgage style foreclosure process is utilized, resulting in a much more efficient process, with attorney involvement throughout. This process in initiated with a demand letter for payment, which regularly results in payment without any other part of the process being utilized. In my opinion, the inclusion of this process is necessary to insure that the tax collections rate is kept at the maximum amount achievable.

Prior to enforced collections being utilized, a property owner is notified by billings in July of each year, second notices which are mailed in January of each year, advertisement in the newspaper which is scheduled for April of each year, and various other communications that are mailed directly from this office. Processes for payment also include pre-payments, which allow a property owner to divide his or her tax bill into twelve (12) "pre-payments" prior to the bill being issued or partial payments after the bills are issued and prior to the delinquency date.

Processing and balancing of fund collection reports are issued to the finance office on a daily, monthly, and yearly basis.

The increase in the use of enforced collections and other collection procedures has resulted in the tax collection rate being over 98% for the past four (4) years, with the 2024 collection rate being 98.43%.
